**\*4)** Where several documents are issued together to the citizen, a total fee of AED 180 shall be charged. Though regarding passport it will be per issued passport.

**\*5)** Provided the request for VAT refund comprises several seperate purchases, a fee of AED 140 shall be charged per statement

**\*6)** Where several provisional passports or extensions of passports are issued at the same time, a fee of AED 1,660 shall be charged for the first passport and AED 710 or AED 1035 for subsequent passports.

**\*7)** Where several provisional passports or extensions are issued at the same time a fee of AED 2,090 shall be charged for the first passport and AED 710 or AED 1035 for subsequent passports.

**\*8)** The Fee may increase to AED 550 or AED 735 if an implementation decision has been adopted in the EU in accordance with the Visa Code Article 25a. Does not apply to children up to and including eleven years of age.
