The Consulate recommends that you do not buy a plane ticket before your visa has been approved.		
 8. Invitation Letter signed by the host covering the period of the intended stay. A copy of ID card or bio data page of the host's passport; residence permit, proof of residence (property title deeds, rental agreements etc., proof of income).
