 6. Proof of Travel Medical Insurance The insurance coverage must be valid throughout the territory of the Schengen area and for your entire stay. The minimum coverage accepted is EUR 30,000. 		
7. Round trip reservation and detailed itinerary including dates and flight numbers specifying the dates of entry and exit from the territory of the Member States. The Consulate recommends that you do not buy a plane ticket before your visa has been approved. If the applicant does not intend to South Africa but either go to his/her country of origin or another this country, a reasonable proof of their intention is needed e.g. work contract in the new destination, or proof of enrolment in university/school or a rental agreement.	ird	
 Signed and dated invitation letter from the Danish host. If applicant is staying with a relative or friend, an invitation letter mentioning this must be submitted. The invitation letter must specify the host's name as well as applicant's name, address, birthdate, official identification number, occupation, and permanent address. Additionally, the purpose of the visit, length of stay, and accommodation status (where the application will stay and who pays for it). Optional: VU2 invitation from www.nyidanmark.dk If expenses are covered by the host this needs to be clearly stated in the invitation letter.
