<b>4. UAE residence permit</b> valid three months beyond the intended date of departure from the territory of the Member States or, for GCC citizens, a UAE-ID-card, valid for three months after the intended departure date from the territory of the Member States.		
<b>5. 1 passport photo:</b> max. 6 months old, on white background, measuring 3.5 x 4.5 cm.		
<b>6. Proof of Travel Medical Insurance</b> <ul style="list-style-type: none"> <li>The insurance coverage must be valid throughout the territory of the Schengen area and for your entire stay.</li> <li>The minimum coverage accepted is EUR 30,000.</li> </ul>		
<b>7. Copy of flight reservation</b> including return flight (travel itinerary indicating intended travel dates).  <b>The Consulate recommends that you do not buy a plane ticket before your visa has been approved.</b>		
<b>8. Invitation</b> <ul style="list-style-type: none"> <li>Letter signed by the host covering the period of the intended stay.</li> </ul> <b>Study or training</b> <ul style="list-style-type: none"> <li>A certificate of enrolment at an educational establishment for the purposes of attending vocational or theoretical courses within the framework of basic and further training.</li> <li>Student cards or certificates of the courses to be attended.</li> </ul> <b>Optional:</b> <a href="#">VU1 or VU3 invitation</a>		
<b>9. Proof of accommodation</b> <ul style="list-style-type: none"> <li>Hotel reservation.</li> <li>Proof of rental or ownership of real estate in the Member State of destination.</li> <li>Confirmation of accommodation by the company inviting the applicant, mentioning that the company will cover the accommodation costs.</li> </ul>

In case of minors (&lt; 18 years):</b></p> <ul style="list-style-type: none"> <li>• Cover letter signed by both parents.</li> <li>• Minors travelling without their parents/legal guardian: original authorisation signed by their parents/legal guardian in front of a visa officer or duly legalised and copy of passport(s) of parents/legal guardian.</li> </ul>
