7. Round trip reservation and detailed itinerary including dates and flight numbers specifying the dates of entry and exit from the territory of the Member States.  The Consulate recommends that you do not buy a plane ticket before your visa has been approved.  If the applicant does not intend to return to South Africa but either go to his/her country of origin or	
another third country, a reasonable proof of their intention is needed e.g. work contract in the new destination, or proof of enrolment in university/school or a rental agreement.	
In case of a pre-paid tour, details of the tour from the tour operator should be provided.	
8. Proof of accommodation for the duration of the intended stay.	
<ul> <li>9. Proof of sufficient means of subsistence during the intended stay;</li> <li>Bank statement for the past 3 months, or proof that expenses are covered by a sponsor or another source.</li> </ul>

<ul> <li>A letter from company stating monthly wages, continuing employment after period of leave and duration of vacation.</li> <li>If self-employed: Certification from SA Companies and Intellectual Property Commission or SA Revenue Service.</li> <li>For students: Letter from school, college or university in South Africa certifying the student status of the applicant.</li> </ul>	
<ul> <li>11. In case of minors (&lt; 18 years): <ul> <li>Cover letter signed by both parents.</li> <li>Minor's birth certificate.</li> <li>Certified copies of ID/passport of both parents.</li> <li>If the minor travels alone; certified parental consent by both parents.</li> <li>If the minor is traveling with only one parent, the other parent must produce certified consent. If only one parent has guardianship of the minor, copies of the relevant court documents must be presented.</li> </ul> </li> </ul>
