	Cover letter from apply Visa duly completed and receipt of application fee payment
	One recent (less than six months old) <b>passport-size photograph</b> in color with good resemblance (3.5cm / 4.5cm)
	<b>Current passport</b> should be valid for at least three months beyond the intended duration of stay in the Schengen area. The passport must have at least two blank pages to affix the visa. Copies of passport pages must be in colour.
	<b>Copy of stamps and visas in previous passports</b> or original passport (if any) + colored copies of bio page(s), previous Schengen visas and stamps, and copy of previous and current residence permit (s)/ Emirates ID with three month validity after return of travel
	<b>Invitation letter issued by the host in Denmark.</b> The letter must specify applicant's name, address, relationship with the reference (proof to be attached), duration of stay & which costs will be covered by host
	<b>Overseas travel medical insurance valid for all Schengen-countries.</b> The insurance has to cover the applicant for the entire duration of the stay in the Schengen area and must cover for at least 30,000 EUR for all risks, e.g. accident, illness, medical emergency evacuation, pandemics incl. COVID-19 etc.
	<b>Flight Itinerary</b> for round trip.
	<b>Evidence of host's status in the Schengen area:</b> passport bio page and documentation of residence
	<b>Proof/Justification of relationship with host</b> (e.g. relevant birth and marriage certificates, divorce certificates, photos/communication with host, etc.)
	<b>Proof of social ties to home country</b> (marriage certificate, birth certificates of children, etc. if relevant)
	<b>Evidence of source of financial support/ means of subsistence</b> <ul style="list-style-type: none"> <li>Original personal bank statement showing movements in the last three months and duly stamped and signed by the bank.</li> </ul> <b>Please note that ALL applicants have to provide proof of pocket money in their own name even if their trip is fully sponsored.</b> <p><b>Please visit:</b> <a href="https://www.nyidanmark.dk/en-GB/You-want-to-apply/Short-stay-visa/Private-visits-and-tourist-visits-">https://www.nyidanmark.dk/en-GB/You-want-to-apply/Short-stay-visa/Private-visits-and-tourist-visits-</a></p> <ul style="list-style-type: none"> <li>For employees: a sealed copy of the business licence of the employing company, a letter from the employer (with English translation) on official company paper with stamp, signature, date and clearly mentioning: address, telephone and fax numbers of the employing company, the name and position in the employing company of the countersigning officer, the name, position, salary and years of service of the applicant as well as an approval for leave or absence.</li> <li>For retired persons: Proof of pension or other regular income.</li> <li>For unemployed adults: If married: Letter of employment and income of the spouse + Notary certificate of marriage, legalised by MFA. If single/divorced/widow/widower: Any other proof of regular income.</li> <li>In case applicant is the proprietor/owner of the company: company Commercial License, company's bank statement, tax clearance receipt, etc. are required</li> <li>If student: <b>Introductory letter from School printed on school's letterhead, school ID, admission letter and academic transcripts</b> if relevant</li> </ul>
	<b>In case of minors (&lt; 18 years) traveling:</b> <ul style="list-style-type: none"> <li>If the minor is traveling with only one parent, written consent of the other parent or guardian, except in cases of a parent having sole custody or guardianship of the minor. Documentation of custody must also be provided.</li> <li>If the minor travels alone (without parents), written consent (including contact details) from both parents or guardians having custody of the minor.</li> <li>A photocopy of both parents' passports. If not, copies of the ID cards (with signature) of the parents.</li> <li>Birth certificate for the minor</li> </ul> <b>Note: If minor traveling with one parent. All the above documents of the other parent are required.</b>
